#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the District. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of Island County Cemetery District No. 1 from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

#### INFORMATION ABOUT THE DISTRICT

Island County Cemetery District No. 1 provides cemetery services to the northern portion of Whidbey Island.

An elected, three-member Board of Commissioners directs the District. The District's Caretaker supervises daily operations and the District's Secretary handles administrative tasks. The District has three permanent employees. The District operated on revenues of approximately \$196,000 in 2013 and \$160,000 in 2014, primarily from property taxes and cemetery sales.
