AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated July 28, 2015, related to procurement of public works projects and purchases. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Thurston County Fire Protection District No. 3 from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meeting minutes
- General revenue and expenditure trend
- Financial condition
- Small and attractive assets
- Procurement
- Public works
- Purchases

Financial

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Federal Summary section of the financial statement and single audit report issued in August 2015.

INFORMATION ABOUT THE DISTRICT

Thurston County Fire Protection District No. 3, doing business as Lacey Fire District 3, was created in 1948. The District serves an area covering approximately 70 square-miles and approximately 90,000 residents in Thurston County. The District provides fire and life safety services through emergency response, education and code enforcement.

An elected, five-member Board of Commissioners governs the District since the annexation of the city of Lacey in 2010. Board Members serve staggered, six-year terms. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 104 full-time firefighters, paramedics, administrative employees and 50 volunteers. For 2013 and 2014, the District operated on annual budgets of approximately \$15 million and \$17 million, respectively.
