AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Cowlitz County Cemetery District No. 1 from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE DISTRICT

Cowlitz County Cemetery District No. 1 provides cemetery maintenance and operation services. The District includes the city of Castle Rock and areas to the west, north and east but does not include the city of Toutle.

An elected, three-member Board of Commissioners governs the District. Commissioners serve six-year terms. The District's annual revenue for 2012, 2013 and 2014 was \$63,489, \$68,682 and \$85,815, respectively. The District's main sources of revenue are from property taxes and cemetery plot sales.
