#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of King County Fire Protection District No. 37 from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

#### **INFORMATION ABOUT THE DISTRICT**

King County Fire Protection District No. 37 covers 10.75 square miles within the city of Covington and unincorporated King County. The District is part of the Kent Fire Department Regional Fire Authority (RFA). The District exists as a Washington State Municipal Corporation solely for the purpose of providing governance for the RFA.

The District is governed by an elected, three-member Board of Commissioners.
