### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Yakima-Tieton Irrigation District from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Finacial condition
- Open public meetings
- Cash receipting

- Disbursements
- Credit cards
- Payroll

#### **Financial**

That report includes a finding for a material weakness in internal controls over financial reporting regarding financial statement preparation and journal entries.

### INFORMATION ABOUT THE DISTRICT

The Yakima-Tieton Irrigation District provides irrigation service to 27,900 acres in Yakima County. The District operates on a closed-pressure pipe distribution system, which includes a regulating reservoir, pump station, two hydroelectric generating facilities and other necessary equipment.

The District is governed by an elected, five-member Board of Directors. The District operates on an annual budget of approximately \$4 million and has 20 full-time employees.
