## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Whitman Hospital and Medical Center from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Contracts/agreements
- Financial condition
- Third party cash receipting

## INFORMATION ABOUT THE DISTRICT

Whitman County Public Hospital District No. 3, doing business as Whitman Hospital and Medical Center, is licensed to operate a 25-bed, acute-care hospital in Colfax. The District offers an array of medical services including surgery, labor and delivery and 24-hour emergency care, in addition to other inpatient and outpatient services.

An elected, five-member Board of Commissioners, comprised of community members, governs the District. Commissioners serve staggered, six-year terms. The Board appoints a Chief Executive Officer to oversee the District's daily operations and its approximately 200 employees. In fiscal year 2014, the District had operating expenses of approximately \$23.3 million.
