## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Shelton from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Court financial operations
- Financial condition
- Police department
- Citizen hotline concern

## INFORMATION ABOUT THE CITY

The City of Shelton is located in Mason County and serves approximately 9,995 citizens. The City provides an array of services including water supply/distribution, sewer collection/treatment, sanitation, storm drainage collection, police, judicial, fire, street maintenance, parks and recreation, building, planning and economic development.

The City has a commission form of government and is the last remaining city in the state to use this form of government. The Commission is composed of a Mayor, Commissioner of Finance and Commissioner of Public Works. The Commission appoints management to oversee the City's daily operations as well as its 94 employees. For 2014, the City's general fund operated on an annual budget of approximately \$12.9 million.
