AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Chehalis from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General revenue and expenditures
- Open Public Meetings Act
- Financial condition
- Self-insurance unemployment compensation
- Cash receipt testing
- Police Department
- Municipal Court
- Small and attractive assets

- Transportation Benefit District formation
- Utility adjustments
- Key system controls:
 - Cash receipting
 - Disbursements/credit cards
 - Payroll
 - Utility billing

Financial

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report issued in August 2015.

INFORMATION ABOUT THE CITY

The City of Chehalis serves approximately 7,370 citizens in Lewis County. The City provides services including fire and police protection, parks and recreation activities, street and bridge maintenance, land use, planning and zoning, court and general administration services. In addition, the City operates its own water, wastewater and storm utilities as well as an airport.

An elected, seven-member Council governs the City. The Council selects one of its members to serve as Mayor. In addition, the Council appoints a City Manager to oversee the City's daily operations as well as its 89 employees. In 2014, the City operated on a \$9.9 million general fund budget.
