AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Wishkah Valley School District No. 117 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

INFORMATION ABOUT THE DISTRICT

Wishkah Valley School District No. 117 provides educational services to nearly 129 students in kindergarten through 12th grade in Grays Harbor County. In addition to providing basic education, the District provides supplemental programs and learning opportunities for students such as special education, food services and transportation services.

The District's five-member Board of Directors is the primary policy-making body, exercising budgetary and financial control for the District. Board Members are elected to staggered, fouryear terms. The Board appoints a Superintendent to oversee the District's daily operations as well as a staff of approximately 30 employees. The District's general fund operating budget is approximately \$2.5 million.
