## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Bellingham from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility billing
- Permitting
- Credit cards
- Self-insurance
- Payroll and benefits
- Small and attractive assets
- Rental contracts
- Endowment funds

## INFORMATION ABOUT THE CITY

The City of Bellingham encompasses approximately 28 square miles of Whatcom County and serves approximately 82,000 citizens. The City provides an array of services including water, sewer, police, Municipal Court, fire, emergency medical, parks and recreation, library, museum, cemetery, golf course, public improvements, planning and economic development. The City contracts out solid waste collection and disposal.

An elected, seven-member Council and a separately elected Mayor govern the City. The Mayor appoints senior management to oversee the City's daily operations as well as its 846 budgeted employees. In fiscal year 2014, the City had an operating general fund budget of \$71 million.
