## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, Board operations complied with applicable requirements and provided adequate safeguarding of public resources. The Board also complied with state laws and regulations and its own policies in the areas we examined.

However, we noted certain matters that we communicated to the Board. We appreciate the Board's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the Grant County Water Conservancy Board from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Board's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

## INFORMATION ABOUT THE BOARD

The Grant County Water Conservancy Board was established in 1999 to provide local processing of water right transfer applications and records of decision for Grant County.

The Board is governed by a three-member board of commissioners appointed by the County. The District operated on revenues of \$39,403 in 2012, \$11,800 in 2013, and \$3,019 in 2014, primarily from application and processing fees, and a local grant in 2012.
