## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated August 10, 2015, related to cash receipting. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the Tukwila Metropolitan Park District from August 16, 2011 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Grant compliance
- Procurement – competitive bid law
- Scholarship procedures
- Credit cards
- Financial reporting
- Cash receipting
- Inter-local agreements

## INFORMATION ABOUT THE DISTRICT

The Tukwila Metropolitan Park District is a municipal corporation organized and operating pursuant to chapter 35.61 RCW. A ballot measure in August, 2011 authorized creation of the District, coextensive with the City of Tukwila's boundaries pursuant to RCW 35.61, including the authority to levy a general tax on property with the District each year, not to exceed 15 cents per thousand dollars of assessed valuation, for the purpose of acquiring and operating a pool facility.

The Tukwila City Council Members serve on the Board of Commissioners, acting in an ex-officio capacity. The Tukwila Pool is a 15,650 square-foot facility that resides on land leased from the Tukwila School District. The pool is located at 4414 S. 144th Street, Tukwila, WA 98168, next to Foster High School. Features include a six lane competition style pool that varies in depth from a three-foot shallow end to a 12-foot deep end. This is the District's first audit.
