## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Grapeview School District No. 54 from September 1, 2012 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

## INFORMATION ABOUT THE DISTRICT

Grapeview School District No. 54 serves approximately 200 students in kindergarten through eighth grade in Mason County. High school students attend either North Mason or Shelton School districts.

An elected five-member Board of Directors governs the District. The Board appoints a part-time Superintendent to oversee the District's daily operations as well as its approximately 30 full- and part-time employees. For the year under audit, the District operated on a General Fund annual budget of \$2.2 million.
