## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Steptoe School District No. 304 from September 1, 2013 through August 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance.

## INFORMATION ABOUT THE DISTRICT

Steptoe School District No. 304 serves approximately 32 elementary students in Whitman County.

An elected, five-member Board of Directors has oversight responsibility for the District and appoints a Superintendent who is responsible for the day-to-day operations. The annual operating budget for the District is \$882,565.
