AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated November 23, 2015, related to the District's imprest fund and debit card transactions. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Lake Wenatchee Water District from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- General disbursements
- Conflict of interest
- Compliance with federal loan requirements
- Imprest fund and debit card transactions
- Utility billing and receipting

INFORMATION ABOUT THE DISTRICT

The Lake Wenatchee Water District was established in 2006 to create an integrated water supply and distribution system to replace the five private community associations providing water along the north shore of Lake Wenatchee. The District formally assumed management and operation of the systems on August 1, 2012. The District's retail water service area covers approximately four square miles and encompasses private and USFS lands.

The District is governed by an elected, three-member Board of Commissioners and has one part-time secretary and one part-time clerk. For fiscal years 2012, 2013 and 2014, the District operated on budgets of approximately \$20,600, \$62,000 and \$56,000, respectively.
