## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Asotin County Health District from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Permits - billing and receipting
- Open public meeting minutes
- Self-insurance
- Financial condition
- Vendor payments/expenditures
- Contracts/agreements
- Gifting of public funds
- Credit cards and accounts
- Payroll leave accruals

## INFORMATION ABOUT THE DISTRICT

The Asotin County Health District was formed in 1986 to provide public health services to the citizens of Asotin County. The District provides an array of programs and services including immunizations, tobacco prevention, and women, infant and children programs.

A six-member Board of Health governs the District. The Board includes three Asotin County Commissioners, one representative from the city councils of Asotin and Clarkston and the Mayor of the City of Clarkston. The Board appoints an Administrator to oversee the District's daily operations and its six employees. In 2012, 2013 and 2014 the District received operating revenues of approximately \$727,000, \$680,000 and \$540,000, respectively.
