AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Lewis County from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- General revenue and expenditures
- Procurement:
 - On-call contracts
 - In-house labor for public works
- Compensation of executive management
- Compensation of public officials

- Utility billing and adjustments
- Travel disbursements
- Cash receipting controls
- Small and attractive assets
- Financial condition
- Merit pay

INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Lewis County was formed in 1936 and commenced operations in 1939. The District is organized in two primary operating systems: The Electric Distribution System and the Cowlitz Falls Hydroelectric Project. The Electric Distribution System provides retail electricity to approximately 31,800 customers and also operates a fiber optic system used for utility purposes and wholesale customers. The Cowlitz Falls Hydroelectric Project was jointly developed with the Bonneville Power Administration (BPA) and completed in 1994. The District signed a Power Purchase Agreement with BPA for all of the generation of the project and, in exchange, BPA pays the entire project's operations and maintenance costs and debt service through September 30, 2032.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its approximately 105 employees. For fiscal years 2013 and 2014, the District's Electric Distribution System generated annual operating revenues of approximately \$61.4 million and \$66.2 million, respectively.
