AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated November 17, 2015, related to annual report filing, open public meetings and payroll. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Thurston County Cemetery District No. 2 from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Annual report filing
- Open Public Meetings Act
- Cash receipting
- Payroll
- Disbursements

INFORMATION ABOUT THE DISTRICT

Thurston County Cemetery District No. 2 maintains and operates a cemetery near Yelm.

The District is governed by an elected, three-member Board of Commissioners. Disbursements are approved at monthly Board meetings and are processed through the Thurston County Auditor's Office. The District has two full-time employees. The District's operating budget for 2013 and 2014 was \$145,859 and \$147,617 respectively.
