AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated November 16, 2015, related to inadequate internal controls and City monitoring of Gold Mountain Golf. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Bremerton from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Financial condition

• Small and attractive assets

• Utility billing adjustments

• Payroll timekeeping methods

• Gold Mountain Golf Course

INFORMATION ABOUT THE CITY

The City of Bremerton serves more than 39,056 citizens in Kitsap County. An elected, seven-member Council and an independently elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its approximately 325 employees. The City is funded by a variety of revenue sources, including property taxes, sales taxes, business taxes, utility charges for services and grants.

The City provides an array of services including water, sewer and stormwater utility systems, law enforcement, municipal court, fire protection/emergency medical services, infrastructure construction and maintenance, parks and recreation facilities/activities, community service programs, planning zoning and economic development and finance and administration. It also operates its own golf course, conference center and cemetery.
