AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of King County Water District No. 54 from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings/receivables
- Cash receipting

- Payroll
- Open public meeting minutes

King County Water District No. 54 was formed in 1935 to provide water service to customers within the cities of Des Moines and Normandy Park.

The District has three employees and operated on an annual budget of approximately \$940,000 for 2014. The District had approximately \$2.07 million in long-term debt as of December 31, 2014. The District is governed by an elected, three-member Board of Commissioners.
