## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated January 20, 2016, related to cash receipting. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the South Whidbey Parks and Recreation District from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Financial reporting
- Third party receipting
- Payroll disbursements
- Financial condition

## INFORMATION ABOUT THE DISTRICT

The South Whidbey Parks and Recreation District was formed in 1986 and provides recreational opportunities for approximately 15,000 citizens. The District has approximately 350 acres of parks and other facilities located in Langlely on the south end of Whidbey Island.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Director to oversee the District's daily operations as well as its six full-time employees. The District receives most of its revenue from property taxes and program fees. For fiscal years 2013 and 2014, the District had revenue of \$756,143 and \$741,265, respectively.
