AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Public Utility District No. 1 of Clallam County from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Use of in-house labor
- Payroll disbursements
- Bid law

- Maintenance inventories
- Self-insurance
- Petty cash
- Financial reporting

INFORMATION ABOUT THE DISTRICT

Public Utility District No.1 of Clallam County provides electric, water and sewer service to residents of Clallam County. The District also provides wholesale telecommunications service. The District provides electric service to approximately 31,000 customers, water service to approximately 5,500 customers and sewer service to 200 customers.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its approximately 150 employees. The primary source of revenue comes from electric services. For fiscal year 2014, the District operated on an annual budget of approximately \$61 million.
