### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Silver Lake Water District from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• General disbursements

- Third party cash receipting
- Open public meetings compliance

### INFORMATION ABOUT THE DISTRICT

Silver Lake Water District was organized in 1934 to construct, maintain and operate water and sewer systems within its boundaries in south Snohomish County. Encompassing 12 square miles, the District provides water service to 17,500 customers and sanitary sewer service to 16,250 customers. Water is purchased solely from the City of Everett. Sewage is pumped to the City of Everett's sewage treatment plant and to King County Metro for treatment. In 2006, the District changed its name from Silver Lake Water District to Silver Lake Water and Sewer District.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to oversee the District's daily operations as well as its 28 full-time employees. In fiscal years 2013 and 2014, the District had operating revenue of approximately \$16.7 million and \$17.8 million, respectively.
