#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, County operations complied with applicable requirements and provided adequate safeguarding of public resources. The County also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Spokane County from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the County's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Contracts/agreements
- Conflict of interest
- Use of restricted funds
- Self-insurance requirements
- Procurement (bid law/purchase cards)
- County Assessor (property taxes/assessments)
- Fair & Expo Center (cash receipting/contracts)

- Public Works (safeguarding of small & attractive assets)
- Spokane County Regional Animal Protection Services (cash receipting)
- Superior Court (cash receipting/collections)
- Transfer stations (cash receipting/contracts)
- Parks & Recreation (cash receipting/contracts)

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the County's major federal programs, which are listed in the Federal Summary section of the separate financial statement and single audit report. ### **INFORMATION ABOUT THE COUNTY**

Spokane County is the fourth largest county in the state with an estimated population of 484,500 residents. The local economy has traditionally relied on forest products, agriculture and mining. However, it has diversified to include technology firms, manufacturing companies and service industries. The County is also home to Fairchild Air Force Base, several institutions of higher education and large medical centers.

The County is governed by an elected, three-member Board of Commissioners. Additional elected officials and the appointed Chief Executive Officer oversee the County's daily operations and its 1,900 employees. The County provides services including public safety, road systems, recreational opportunities, court services, election services, regional planning, and property valuations and tax collections. For fiscal year 2014, the County operated on an annual general fund budget of approximately \$163 million.
