#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Carnation from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Third party cash receipting
- Procurement (bidding/prevailing wage)
- Credit card expenditures
- Financial condition

#### Financial

#### **INFORMATION ABOUT THE CITY**

The City of Carnation serves approximately 2,000 King County residents. The City is located east of the main population center of King County, in the lower Snoqualmie River Valley and is surrounded by unincorporated King County. The City provides water and sewer services, parks and recreation programs, public works and community and economic development services. The City contracts with the City of Duvall for police services and with a separate vendor for solid waste collection.

An elected, five-member Council governs the City. The Council selects one of its members to serve as Mayor. In addition, the Council appoints a City Manager to oversee the City's daily operations as well as its 10 employees. For 2014, the City operated on an annual budget of approximately \$7.3 million.
