AUDIT SUMMARY

Results in brief

In the areas we audited, Commission operations complied with applicable requirements and provided adequate safeguarding of public resources. The Commission also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Washington State Commission on Asian Pacific-American Affairs from July 1, 2013 through June 30, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Commission's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Donations
- General disbursements

- Credit cards and accounts
- Travel

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE COMMISSION

In January 1972, Governor Evans created The Governor's Asian Advisory Council by executive order. On February 26, 1974, the 43rd Washington State Legislature formally created the Washington Commission on Asian American Affairs as a state agency. On April 17, 1995, Governor Mike Lowry signed a bill to change the Commission's name to The State of Washington Commission on Asian Pacific-American Affairs to include Pacific Islanders. The Commission's 40 year history marks a legacy of advocacy, community education and outreach, as well as interagency and community collaborations to improve the wellbeing of the Asian Pacific-American communities.

The Commission has an Advisory Board made up of 12 Governor-appointed Commissioners, representing the state's rich Asian Pacific-American diversity. Each Commissioner serves a three-year term and may serve for two consecutive terms. The Commission advises the Governor and state agencies on issues that concern the Asian Pacific-American community. The Commission's only office is in Olympia and it is staffed with an Executive Director and a Project Coordinator. For the 2013-2015 biennium, the Commission's operating budget was approximately \$418,000. The Commission also receives gifts, grants and endowments from public or private sources.
