## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Douglas County Sewer District No. 1 from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Utility billing and adjustments
- Procurement (bidding)
- General disbursements

## INFORMATION ABOUT THE DISTRICT

Douglas County Sewer District No. 1 provides sewer service in the East Wenatchee area of Douglas County. The primary source of revenue for the District comes from sewer and connection fees. The District has experienced significant growth in the past several years due to increased development in the area.

The District is governed by an elected, three-member Board of Commissioners. The Board is responsible for appointing the District Manager, who oversees most of the District's daily operations as well as its 11 employees. For fiscal years 2013 and 2014, the District generated operating revenues of \$3.6 million and \$3.7 million, respectively.
