## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Othello School District No. 147 from September 1, 2013 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance
- Cash receipting
- Small and attractive assets
- Procurement
- Associated Student Body
- General disbursements
- Credit card disbursements
- Payroll

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the District's financial statements. ## INFORMATION ABOUT THE DISTRICT

Othello School District No. 147 serves over 4,000 students in kindergarten through 12th grade in Adams County. The District has three elementary schools, one middle school, one high school and one nontraditional school.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent who oversees the District's daily operations as well as its approximate 435 employees. The District operated on revenues of \$41 million during fiscal year 2015.
