## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Skagit County Fire Protection District No. 8 from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll
- Disbursements

• Open Public Meetings Act

## INFORMATION ABOUT THE DISTRICT

Skagit County Fire Protection District No. 8 serves an area covering approximately 60 square miles in Skagit County. The District owns three fire stations: Hickson Station, Prairie Station and Punkin Center Station, and also contracts with the Town of Lyman to operate the Lyman Station.

The District is governed by an elected, three-member Board of Commissioners. The Board appoints a full-time Fire Chief to oversee the District's administrative assistant and over 40 volunteer firefighters. The District's main source of revenue is derived from property taxes and fire protection services provided under contract with other municipal entities. Its annual operating budgets for 2014 and 2015 were \$1,607,400 and \$894,750, respectively.
