## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Naches Valley School District No. 003 from September 1, 2013 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Self-insurance/risk management
- Open Public Meetings Act
- Payroll

- Associated Student Body
- Conflict of interest
- Payments/expenditures
- Surplus property

## INFORMATION ABOUT THE DISTRICT

Naches Valley School District No. 003 provides educational services to approximately 1,325 students in Yakima County. The District operates a primary school, intermediate school, middle school, and high school to provide basic and special education services, transportation, meals, and extracurricular activities.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent to oversee the District's day-to-day operations as well as its approximately 90 certified and 60 classified employees. For the years under audit, the District operated on general fund budgets of approximately \$21 million.
