AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most of the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated May 12, 2016, related to Career and Technical Education enrollment. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Raymond School District No. 116 from September 1, 2014 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- Career and Technical Education
- Self-insurance
- Credit card expenditures
- Travel
- Payroll (high risk transactions)

- General revenues and expenditures (trend analysis)
- Associated Student Body (trend analysis)
- General disbursements
- Cash receipting
- Conflict of interest

INFORMATION ABOUT THE DISTRICT

Raymond School District No 116, located in Pacific County, has approximately 563 students in preschool through 12th grade. There are two main schools including Raymond Elementary and Raymond Junior-Senior High. In addition, there are two alternative learning options including the Alternative High School and a parent-school partnership called HomeLink with 97 students. The District is also a member of the Columbia Virtual Academy.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 97 employees. The District provides basic education, special education, food services, janitorial services, transportation and school nurse services. For the 2015 fiscal year, the District operated on an annual general fund budget of \$7.3 million.
