### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Soap Lake School District No. 156 from September 1, 2013 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Teacher education and experience (staff mix) reporting
- Self-insurance

- Payroll
- Credit card disbursements

## INFORMATION ABOUT THE DISTRICT

Soap Lake School District No. 156, located in Grant County, serves approximately 530 students in kindergarten through 12th grade. The District has one combined high school and middle school, one elementary school and an alternative education site. Most of the District's funding comes from state funding. The District operates on an annual budget of approximately \$6.2 million.

A five-member Board of Directors, elected to four-year terms, governs the District. The Board appoints a Superintendent who is responsible for oversight of the District's daily operations as well as its 75 employees.
