## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Cascade School District No. 228 from September 1, 2013 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Third party cash receipting
- Self-insurance (unemployment compensation)
- Student enrollment reporting
- Payroll

## INFORMATION ABOUT THE DISTRICT

Cascade School District No. 228 is located in Chelan County in Leavenworth, Washington and provides educational services to approximately 1,200 students from kindergarten through 12th grade. The District has one high school, one middle school, three elementary schools and an alternative education site.

A five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations, as well as its approximately 130 employees. The District had approximately \$12.4 million and \$13.4 million in expenditures for fiscal years 2014 and 2015, respectively.
