AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Highland School District No. 203 from September 1, 2013 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance
- General disbursements including credit card use
- Cash receipting High School and Junior High School
- Conflict of interest
- Special education enrollment
- Open Public Meetings Act
- Staff mix

INFORMATION ABOUT THE DISTRICT

Highland School District No. 203 provides educational services to 1,190 students in kindergarten through 12th grade in Yakima County. More specifically, the District provides basic elementary, middle school, junior high school, high school, vocational education, bilingual education, pupil transportation, food services, special education for handicapped students and numerous special programs for remedial and enriched education.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations, as well as its certified and classified employees. For the period under audit, the District operated on annual budgets of approximately \$12.9 million.
