## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Arlington School District No. 16 from September 1, 2012 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting (Associated Student Body and food services)
- Donations
- Procurement
- Self insurance
- Apportionment – teacher education and experience (staff mix)
- Financial condition
- Open Public Meetings Act compliance

## INFORMATION ABOUT THE DISTRICT

Arlington School District No. 16 provides education services to students in preschool through 12th grade. The District's service area includes the City of Arlington and neighboring unincorporated portions of Snohomish County. The District serves nearly 5,200 students with a staff of approximately 294 certificated, 165 classified and 22 administrative employees. The District operates two high schools, including one alternative high school, two middle schools, five elementary schools and one K-12 school.

An elected, five-member Board of Directors governs the District. General fund expenditures totaled \$47,903,912 in fiscal year 2013, \$50,986,161 in fiscal year 2014 and \$54,606,048 in fiscal year 2015.
