AUDIT SUMMARY

Results in brief

In the areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Spokane Transit Authority from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Safeguarding of equipment, tools and parts inventory
- Payroll/personnel
- Non-revenue vehicle use
- Fuel use
- Self-insurance requirements

INFORMATION ABOUT THE AUTHORITY

In 1981, Spokane County residents approved a public transportation benefit area, creating Spokane Transit Authority. The Authority provides a variety of transportation services including 34 fixed bus routes with service to the cities of Airway Heights, Cheney, Liberty Lake, Medical Lake, Millwood, Spokane, Spokane Valley and portions of unincorporated Spokane County. The Authority provides service for approximately 12 million riders per year in its service area of 413,045 citizens.

The Authority's Board of Directors is composed of ten members: nine elected officials chosen from the jurisdictions served by the Authority and one nonvoting labor representative. The Board appoints a Chief Executive Officer to oversee the Authority's daily operations as well as its approximately 530 employees. The Authority is supported primarily by local sales and use tax, grant funding from federal and state agencies and passenger fares. For fiscal year 2015, the Authority had an operating budget of approximately \$66 million.
