### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Seattle Chinatown International District Preservation and Development Authority from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Petty cash

• Payments/expenditures

### **RELATED REPORTS**

#### **Financial**

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Seattle Chinatown International District Preservation and Development Authority.

#### Federal grant programs

A firm of certified public accountants evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Authority's major federal programs. That firm's report is available from Seattle Chinatown International District Preservation and Development Authority.

## **Special investigations**

We noted certain matters that we communicated to Authority management in a letter, relating to a loss of public funds. The Authority self-reported the loss of public funds to our office and subsequently performed its own internal investigation. Upon completion of the investigation, the Authority improved its internal controls and implemented new policies and procedures to address the control weaknesses that led to the loss of public funds. We appreciate the Authority's commitment to resolving those matters.

## INFORMATION ABOUT THE AUTHORITY

The Seattle Chinatown International District Preservation and Development Authority was established by a charter issued by the city of Seattle on December 16, 1975. The purpose of the Authority is to preserve, promote and develop the Seattle Chinatown-International District as a vibrant community and unique ethnic neighborhood.

The Authority owns or manages 433 low-income residential units and 130,000 square feet of commercial and retail space. The majority of the residential properties provide low-income housing. The most significant programs and properties are:

- Bush Hotel, which includes 96 units of affordable housing and 26,000 square feet of commercial and retail space.
- Legacy House, which provides multi-cultural senior housing and services
- International District Village Square, which provides centralized resources for health care, mental health, social services, pre-school and childcare, employment services, senior advocacy, supportive care and housing.
- IDEA Space, which serves as a catalyst for responsible neighborhood investment and a vehicle for strengthening community involvement in revitalization efforts.

During the audit period, the Authority was governed by a Council of up to 17 members. The Mayor of the City of Seattle appointed four members; the constituency of the Authority elected four members, the Authority's Council elected four members and an additional one to five members were selected by the Council. After the audit period, the Council's composition was changed to a Board of Directors. The City does not consider the Authority to be a component unit. The Authority is supported primarily through service agreements and rental income. The Authority's 2014 operating revenues were approximately \$6.9 million. It has approximately 100 employees.
