AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of University Place from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Credit cards & accounts
- Third party cash receipting
- Safeguarding of small and attractive assets, fixed assets
- Payroll/sick leave cash out
- Rental/lease adjustments and cancellations
- Follow up on prior issues

INFORMATION ABOUT THE CITY

The City of University Place was incorporated on August 31, 1995, and serves more than 31,270 Pierce County citizens. The City provides services including construction and maintenance of streets, surface water maintenance, building inspection, planning and zoning, park maintenance, recreation programs and general administration. Many services are contracted through public and private entities including police protection, jail services, Municipal Court, animal control, fire protection, emergency medical services, utilities, public transportation and library services.

The City is a non-charter Optional Code City with a Council-Manager form of government. An elected, seven-member Council governs the City. The Council selects one of its members to serve as Mayor. In addition, the Council appoints a Manager to oversee the City's daily operations as well as its 49 employees. For the audit period, the City operated on a total budget of \$53,667,044.
