#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, Transportation Benefit District operations complied with applicable requirements and provided adequate safeguarding of public resources. The Transportation Benefit District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the University Place Transportation Benefit District from January 1, 2014 through November 16, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Transportation Benefit District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• City restricted funds

- General disbursements
- Formation, merger, dissolution

# INFORMATION ABOUT THE TRANSPORTATION BENEFIT DISTRICT

The City of University Place Transportation District was established by Ordinance No. 634 on December 2, 2013 by the City of University Place City Council. The Transportation Benefit District started collecting revenue June 2014, of a \$20 vehicle license fee collected by the state to support local transportation improvement projects. The state started collecting the vehicle license fee revenues in June, 2014. On November 16, 2015, by City Council Ordinance 660, the City of University Place assumed the rights, powers, functions and obligations of the Transportation Benefit District.
