AUDIT SUMMARY

Results in brief

In the areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Snohomish County Public Transportation Benefit Area from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- Gifts and awards

- Self-insurance
- Open Public Meetings Act

INFORMATION ABOUT THE AUTHORITY

Snohomish County Public Transportation Benefit Area, doing business as Community Transit, was established in 1976. The Authority's service area covers approximately 73 percent of Snohomish County's 757,600 citizens. The Authority's 615 employees provide local and commuter bus service and vanpools. Paratransit service is subcontracted to Senior Services of Snohomish County and the majority of the commuter service is subcontracted to First Transit.

The Authority is governed by a Board of Directors consisting of nine voting members and one non-voting member. The Board of Directors includes two members of the Snohomish County Council, seven elected officials appointed by their respective jurisdictions and one non-voting Labor Representative selected by the Authority's collective bargaining units. The Authority's expenses totaled \$126.6 million in 2015 from the following major sources: operations, maintenance, general and administrative, contracted transportation and depreciation. In 2015, revenue for the Authority totaled \$158.1 million from the following major sources: passenger fares, regional transit service, sales tax and federal and state grants.
