AUDIT SUMMARY

Results in brief

In the areas we audited, Housing Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Housing Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Walla Walla Housing Authority from January 1, 2014 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Safeguarding of inventory
- Donations
- Procurement (bidding/prevaling wage)
- Use of restricted funds

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Housing Authority's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. Special investigations

We noted certain matters that we communicated to Housing Authority management in a letter, relating to loss of Housing Authority inventory. We appreciate the Housing Authority's commitment to resolving those matters.

INFORMATION ABOUT THE HOUSING AUTHORITY

The City of Walla Walla Housing Authority was established in 1973 with the mission to provide decent, safe, sanitary and affordable housing to low-income families including elderly, disabled people and homeless veterans. The Housing Authority owns and manages 198 multi-family units, provides property management for 158 units and administers a Housing Choice Voucher program and Tenant Based Rental Assistance program. The Housing Authority provides housing assistance to more than 1,057 families annually in Walla Walla and Columbia counties.

A six-member Board of Commissioners, appointed by the Mayor of the City of Walla Walla, governs the Housing Authority. The Board is responsible for establishing the vision, goals and policies of the Housing Authority. In addition, the Board appoints an Executive Director to oversee the Housing Authority's daily operations as well as its approximately 29 employees. The Housing Authority is primarily funded with grants provided by the U.S. Department of Housing and Urban Development (HUD) totaling approximately \$5.1 million.
