AUDIT SUMMARY

Results in brief

In the areas we audited, University operations complied with applicable requirements and provided adequate safeguarding of public resources. The University also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Eastern Washington University from July 1, 2013 through June 30, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the University's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Foundation
- Tuition waivers/scholarships
- Cash receipting

- Unrelated business income
- Payroll/personnel
- Payments/expenditures

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Comprehensive Annual Financial Report (CAFR) prepared by and available from the Office of Financial Management.

The CAFR reflects the financial activities of all funds, organizations, institutions, agencies, departments and offices that are part of the state's reporting entity. That report is issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE UNIVERSITY

Eastern Washington University is a regional, comprehensive, public university located in Cheney with programs also offered in Bellevue, Everett, Kent, Seattle, Shoreline, Spokane, Tacoma, Vancouver and Yakima. It was established in 1882 as the Benjamin P. Cheney Academy. In 1977, the University was renamed Eastern Washington University and was designated a regional university. The University's main campus is located on 329 acres, approximately 150 of which are developed, approximately 17 miles southwest of the state's second largest city, Spokane. The University also has a Spokane campus, co-located with Washington State University on 48 acres adjacent to downtown Spokane, which serves over 2,200 students. The University serves both a residential student population as well as utilizing a low-cost bus service from Spokane to accommodate the large number of commuter students. In response to requests to expand access to higher education opportunities in the state, the University partners with Bellevue College, Pierce College, Clark College, South Seattle Community College, Lake Washington Institute of Technology and North Seattle Community College to offer baccalaureate degree completion programs at these locations. The University also offers the Master of Social Work degree program in Everett, Vancouver and Yakima.

The University owns seven residence halls to provide housing and specialized programs for students and offers University-owned apartments designated for families. The University provides housing for approximately 18 percent of students enrolled. The University offers nine dining locations on campus including espresso shops and convenience stores. Students who live in residence halls are required to purchase a residence dining plan.

During the 2015-2016 academic year, the University employed 445 full- and 324 part-time faculty. A significant number of faculty serve or have served as officers of their respective national professional societies. During the same 2015-2016 academic year, the University employed 538 full-time equivalent classified staff and 335 full time equivalent professional and administrative staff in addition to faculty. The operating budget for fiscal year 2016 was approximately \$270 million. The University also had a biennial capital budget of approximately \$47 million. The University's major revenue source is tuition and fees. An eight-member Board of Trustees, appointed by the Governor and confirmed by the Senate, is responsible for operating the multi-campus University as a single, comprehensive, legal entity under the administrative direction of the President.
