AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated July 11, 2016, related to cost allocations to restricted funds. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Tonasket from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll – leave accruals
- Cost allocations
- Utility billing
- Procurement

INFORMATION ABOUT THE CITY

The City of Tonasket is a rural community located in Okanogan County with a population of nearly 1,100 citizens. The City provides an array of services including public safety, Municipal Court, water, sewer, cemetery and airport.

An elected, five member Council and independently elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its 11 employees, and received revenues of approximately \$3.1 million, \$4.4 million and \$1.6 million in 2012, 2013 and 2014, respectively.
