AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Burien from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement: small works
- Cash receipting: Community Center and facility rentals
- Contract compliance
- Credit card payments
- Emergency Voucher Program: gift cards

INFORMATION ABOUT THE CITY

The City of Burien was incorporated in 1993 in King County. An elected, seven-member Council governs the City. The Council elects one member to serve as Mayor to preside over the Council for a two-year term. The Council appoints a Manager to oversee the City's daily operations as well as its 68 full-time employees.

The City of Burien serves approximately 49,000 residents. The City provides a range of services to the public, either directly or through contracts with other governmental agencies and outside vendors including executive, finance, legal, Municipal Court, police, jail, public works, planning and community development, parks, recreation and cultural, library, fire, water and sewer services. The City is funded by a variety of revenue sources, including property taxes, sales taxes, business taxes, charges for services and grants. In fiscal year 2015, the City's general fund operating budget was \$22 million.
