AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Stemilt Irrigation District from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Contract monitoring and payroll
- General disbursements
- Financial condition

INFORMATION ABOUT THE DISTRICT

The Stemilt Irrigation District was established in 1926 to provide irrigation water services to Stemilt users in Chelan County. The District employs one full-time employee for maintaining irrigation lines and pumps and also has a secretary and an on-call employee. The District operates on annual budgets of approximately \$350,000.

The District is governed by a five-member Board of Directors. Each Board Member is elected by voters to serve staggered, three-year terms. They are responsible for establishing District policy and approving District expenditures. Chelan County acts as the ex-officio Treasurer for the District. In addition to collecting the District's revenues, the Treasurer is responsible for investing the District's funds.
