## AUDIT SUMMARY

### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the City of Poulsbo from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Employee time and reimbursements
- Building permits
- Self-insurance
- Municipal court
- Cash receipting

## INFORMATION ABOUT THE CITY

The City of Poulsbo, incorporated on June 14, 1913, provides the following services to approximately 9,950 citizens: water, sewer, garbage, storm drains, police, municipal court, street maintenance, parks and recreation, community service programs, and planning and economic development.

An elected, seven-member Council and a separately elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its 92 employees. For fiscal year 2015, the City operated on an annual budget of \$22 million.
