### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Kittitas County Conservation District from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Yakima Tributary Access and Habitat Program
- Grant billings
- Disbursements

- Open Public Meetings Act
- Payroll
- Procurement

### INFORMATION ABOUT THE DISTRICT

Kittitas County Conservation District is dedicated to protecting the natural resources of Kittitas County. A five-member Board of Supervisors governs the District. Citizens in the District elect three of the Board Members and the Washington State Conservation Commission appoints two of the Board Members.

The District is funded primarily through state and federal grants. The District budgets are directly related to potential grant funding for the following year. Annual budgets are on a fiscal year of July 1 through June 30. For fiscal year July 1, 2013 to June 30, 2014, the District operated on an annual budget of \$4,877,741. For fiscal year July 1, 2014 to June 30, 2015 the District's annual budget was \$3,400,907. In fiscal year 2015, the District had seven full-time employees and occasionally employed temporary, part-time staff.
