AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Maple Valley Transportation Benefit District from January 1, 2015 through December 20, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Dissolution audit
- Revenue recognition – vehicle license fees
- General disbursements

INFORMATION ABOUT THE DISTRICT

A transportation benefit district (TBD) is a quasi-municipal corporation and independent taxing district created for the sole purpose of funding transportation improvements within the district. A TBD is created by ordinance of legislative authority (county or city) and may include other counties, cities, port districts, or transit districts through inter-local agreements.

On November 26, 2012, the City of Maple Valley City Council adopted Ordinances O-12-515 and O-12-516, establishing the Maple Valley Transportation Benefit District and adopted a new chapter to the Maple Valley Municipal Code, 12.35. The District had expenditures of \$206,855 for 2015.

On December 20, 2015, Ordinance O-15-584 dissolved the District and the City of Maple Valley assumed the rights, powers, functions and obligations of the Maple Valley Transportation Benefit District.
