## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Columbia Conservation District from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

## INFORMATION ABOUT THE DISTRICT

The Columbia Conservation District, located in Dayton, was established in 1949 to provide resource conservation project assistance. The District consists of 558,581 acres: 356,775 privately-owned cropland, pasture/rangeland and forest, 187,118 acres publicly-owned lands and 14,688 acres vacation/recreational, incorporated/residential, and other. The County's major industry includes agriculture, recreational winter skiing and seasonal fishing and hunting.

An elected, five-member Board of Supervisors governs the District. Fiscal responsibility, including budget authority, the power to set fees and issue debt consistent with provision of state law, rests with the Board. The District has four full-time employees and in 2015, revenue was approximately \$1,642,133 and expenditures were approximately \$1,615,571.
