AUDIT SUMMARY

Results in brief

In the areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Port of Pasco from January 1, 2015 through December 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Disbursements/valid vendors
- Payroll disbursements
- Procurement
- Sale of land

INFORMATION ABOUT THE PORT

The Port of Pasco was formed in 1940 by the voters of the district. The Port is organized to provide and operate marine terminals, airports and industrial properties. Major facilities owned and operated by the Port include: Big Pasco Industrial Park, which consists of 1.5 million square feet of industrial buildings, located on 600 acres of waterfront land for manufacturing, warehousing, distribution and assembly plant locations. A Marine Terminal located on 28 acres, which handles one of the largest bulk cargo barge tonnage on the Columbia River above the Portland and Vancouver districts. Tri-Cities Airport, which is the regional air carrier airport. Its 1,800 acres of land is available for industrial development with some building space available for rent. Pasco Processing Center is owned and developed by the Port of Pasco. There are currently 40 acres available for purchase. Typical buyers include food processing companies.

An elected, three-member Board of Commissioners governs the Port. The Commissioners appoint management to oversee the Port's operations as well as its 43 employees. The Port operated on an annual budget of approximately \$14.1 million.
